



A MESSAGE FROM REV. NANCY NOURSE

Hindsight is 2020! Isn't it? And what a year it has been. Sunday March 15th the Board of Northminster, at the



recommendation of health officials and the United Church, decided to pause in-person worship because of the spread of Covid 19. Little did we know, this would be continuing one year later. No doubt we are missing our church friends and family, and being able to gather each Sunday, not to mention the many other traditions and events throughout the year. Perhaps this year has left you feeling low about the church. Indeed, there are many emotions we are all feeling. And it's presented it challenges for our staff and volunteers.

At the same time, I want to affirm that church is not closed or cancelled. Northminster continues to be a busy and vital entity, and I really want to celebrate and thank you for what we have done this year.

Offering has gone up! That's right! We surpassed our givings budget by \$10,000!

Embracing Technology – Most of us had never heard of Zoom, and a lot of others had never expressed an interest in trying out Facebook or YouTube – but look at you! Embracing technology as a way of life, and as a way of church life. You've done well to stay connected for meetings and live-streaming worship!

Connecting and Learning - More people than ever are engaging in bible studies. In a normal year we'd average 8-10 people at a seasonal bible study. But this year more than 20 people are signing up to participate in our on-line programs.

You responded so well in adapting to the pandemic. Thank you to all who made extra calls to people in our congregation, who delivered necessities, made prayer shawls, participated in online programs, helped others connect, and were willing to try new ways of being the church. You showed how Northminster cares!

We were still able to celebrate and mark milestones as a church: weddings, funerals, new members.

Music – with Sarah's leadership was a wonderful mix of voices to lead us in favourite hymns online.



The Task Force continued to meet and present some significant proposals to you. And you continue to make decisions with courage and faith and vision for what we need as a church for the future.

Affirming Ministries is still an ongoing discussion as we look at how Northminster can eliminate all barriers to full inclusion and participation in the life of the church.

Youth Group led by Mary Anne was busier than most years because regular activities were cancelled. Youth Group deepened in becoming a very consistent place of connection for our youth through this unusual year.

Our partnership with the City of Calgary continued for Truth and Reconciliation with thanks to a grant we received from the United Church of Canada and our ability to move online.

Mission and Outreach led us in supporting our partners and neighbours like the Aboriginal Friendship Centre through the year, and in assisting local families with Christmas Hampers. Supper Church also moved to an online outreach worship, enjoying video recipes from Craig and family.

We re-invent fundraisers that couldn't happen this year – such as the Turkey Supper and Craft Fair.

We partnered with local United Churches to collaborate on weekly kidZone videos for our children, and we enjoyed a creative virtual Christmas Play in December.

For myself, I am grateful as well for our wider United Church and beyond who still offered support and continuing education opportunities online.

We are a church family who are doing amazing things, have much to celebrate and some challenges ahead. These things are just a sample of wonderful memories I have of this year – despite Covid 19 – of how you have faithfully and joyfully pivoted and persisted in being the church.

I could write more, but I will end with this verse of scripture: "I have much to write to you, but I would rather not write with pen and ink; instead I hope to see you soon, and we will talk together face to face." 3 John 1:13

I took on the Community Engagement Coordinator position in September. It has been a great opportunity for learning and making connections as I work to foster connection between our church and the greater community. As well, my work has been focused on events and activities within our church community and communication through social media.

The pandemic has greatly limited our opportunities for planning and engaging in events in the broader

community. It is my hope that in the second half of my term there will be more opportunity to partner with the wider community as restrictions are eased. Because of the challenges that the pandemic has presented, my role and the work I have done has shifted somewhat to focus on our church community and online communication, recognizing the need to be intentional about keeping our church family connected when we cannot meet in the building.

Events and Activities

In collaboration with Rev. Nancy and other church members I have helped plan and facilitate such events as:

-Campfire Church – booking the venue, preparing the activity, set up, etc.



-Online Paint Night – a fundraiser in support of the Legacy Fund for Canadian Veterans -Supper for the Soul – TRC event with Special Guest Ernie Poundmaker speaking about First Nations Thanksgiving traditions

-Kindness Has No Limit – helped the Affirming Committee to promote the online presentation

-Christmas Greenery Fundraiser – coordinated and organized the fundraiser with support from Barb Johnson in the office

-Fraud and Scam Workshop -although the workshop took place in January, I worked in collaboration in November and December with our City of Calgary social workers in Highland Park and Thorncliffe Greenview and representatives from Carya designing the promotional materials, advertising and managing Eventbrite for signup for the event.

Communication

With amazing support and mentorship from Brad Lavenne I have learned to use Canva to create graphics



and videos and Hootsuite to manage our day-today social media posts to advertise Northminster Church events and initiatives on social media (on Facebook, Instagram and Twitter) for weekly emails and for use during online worship. I have supported committees such as Mission and Outreach, the Affirming Committee and the KidZone team promoting initiatives such as the Bottle Drive, Sponsor a Family, the Kindness Has no Limit presentation and the All-ages KidZone Movies. As well, I am responsible for compiling the quarterly newsletter and helping prepare the advertising for Advent and Christmas in the community newspapers.

I look forward to continuing my work

representing Northminster in the wider community as well as continuing to help foster connection through events, activities, and communication within our church family during these challenging pandemic times.

ADMINISTRATION COMMITTEE DISCUSSION AND ANALYSIS

Overview

The Administration Committee is responsible for the maintenance of the Church building and property and the management of the Church's financial resources. This includes setting budgets, ensuring that members' contributions are deposited and accounted for, rents are negotiated and collected, operating costs are up to date and employees are paid as per the budget. All financial reports are prepared by the Treasurer and all income and donations are reconciled by the Envelope Secretary.

Canada Emergency Business Loan (CEBA)

As a result of the COVID-19 pandemic, Northminster United Church applied for and received a \$40,000 loan from the Government of Canada. This loan is repayable to the Government of Canada and includes a forgivable amount of \$10,000 if \$30,000 of the loan is repaid prior to December 31, 2022.

In February of 2021 Northminster United church applied for and received an extension to our Government of Canada Ioan. This Ioan is repayable to the Government of Canada and includes a forgivable amount of \$10,000 if \$10,000 of the Ioan is repaid prior to December 31, 2022.

The total loan applied for is \$60,000 and the amount that must repaid by December 31, 2022 is \$40,000.

The amount of the original loan of \$40,000 is reflected on our Statement of Financial Position under long term liabilities.

Canada Emergency Wage Subsidy (CEWS)

On March 17, 2020, a state of public health emergency was declared in Alberta as a result of the World Health Organization declaring COVID-19 a global pandemic. As a result, Northminster United Church

applied for the Canada Emergency Wage Subsidy (CEWS) and received \$29,987 as a subsidy from the Government of Canada in response to the impacts of the COVID-19 pandemic.

Thank you to Ted Carter and Ron Hiebert who act as our Building Coordinators. Thank you to the administration team, Dorothy Gautreau, Kim Haydu and Rita San Martin for the many hours involved in managing the Church Finances.

Our thanks also go out to our Church employees and to the many volunteers who give their time and talents throughout the year. Please know that your volunteer work throughout the year does make a difference.

BUILDING COORDINATORS REPORT

The Building Coordinators work in conjunction with the Administration Division. We are tasked with a variety of tasks related to maintenance, repairs and general upkeep of the Church Facility. In some cases we perform maintenance functions, while in other instances we oversee the work of contractors and other vendors who provide services. We also make recommendations to the Administration Division of repairs and maintenance required.

These are a few of the various projects that the Building Coordinators have taken care of during the past year.

Plumbing

Arrange to have our Boiler Maintenance performed two times per year. One took place in January 2020 and the other one in June 2020. The rational is that the boiler will meet the Government Boiler Inspection Code required annually. Involved with the Boiler Inspection we are required to have a certified plumber certify that the Cross Connection Vales are functioning as per the City Of Calgary Bylaws.

Elevator

Arrange to have the Elevator serviced two times per year. We need to have the Elevator Inspected annually to obtain the permit so it can be operated. This is done by the Alberta Elevating devices and Amusement Rides Safety Association.

Fire Extinguishers and Emergency Lighting Devices.

Arrange to have the Fire Extinguishers tested annually to meet the Code requirements. There are ten (10) Fire Extinguishers in the Church. As well we are required to keep a log of the testing of the Emergency Devices monthly to meet the City of Calgary Fire Code.

Sidewalk, Parking Lot Snow Removal and Lawn Care Work with Administration Division recommending Contractors to perform this work and handle any complaints received and work with contractors to have the issue corrected. The Parking Lot and Sidewalk contracts run from October 15 to April 15 of each year. The Lawn Maintenance contact runs from May to September.

The Building coordinators perform light bulb changes as required, as well as tree trimming and changing the sign. We work in conjunction with our Janitorial Contractor Ramiro Mara to ensure he has all the supplies required to do the janitorial work. We perform work to ensure our building is safe and meets all the Civic and Provincial Code requirements.

CONGREGATIONAL LIFE

As we welcomed the year 2020 we had no idea of the changes and challenges that would come about as

a result of a pandemic. Northminster's response to this new reality was to move forward using technology, and our focus shifted from in-person gatherings to virtual gatherings. Livestream & Zooming enabled us to carry on with worship services, regular monthly meetings, social groups and activities. Book Club, Beer with God, Supper Church, our Lenten and Advent studies, Kidzone classes and Youth Group gatherings were all hosted online. We did enjoy a few outside gatherings- Stroll for the Soul and a couple of in-person visits in parks- while following Covid protocols. Following our Ash Wednesday supper in-person gathering at church, Supper Church continued on-line, complete with delicious recipes offered by chef Craig



Benoit. Rev. Nancy led us in our compelling Lenten and Advent studies. Both studies were well-attended with some welcome new participants joining us online.

Due to her professional work commitments Michele Gole stepped away from her position as Community Engagement Coordinator. We are grateful for her commitment to building community, her work with the Truth and Reconciliation Collective and her enthusiastic involvement with our Youth Group when they hosted their Sunday luncheon fundraisers. In October we welcomed Mary Anne Wickerson to the role of Community Engagement Coordinator and she brings to the position enthusiasm, leadership experience and great organizational skills.

Our Kidzone programs continue online. Our coaches have partnered online with St. Thomas, Woodbine, and Symons Valley children's leaders over the months. With fresh ideas, the coaches share faith stories,



conversations and crafts that are relevant to the weekly lessons. Mary Anne has a devoted group of youth who attend classes, Naked Faith nights, game nights and movie nights. During Advent Mary Anne organized a youth fundraiser through the sale of Christmas wreaths and arrangements. Two of the year's highlights were the Easter and Christmas pageants. Our Christmas pageant was an original play written by Rev. Nancy! Our Kidzone teachers did a super job of organizing the production of the plays. This was no small feat considering that the kids were all filmed separately in costume complete with great background scenery. Sincere thanks, to our committed and creative Kidzone coaches-Tracey Abbott, Julie Latter (Spark),

Lindsay Haydu-Kunal and Nicole Vandervoort (Glow) and Mary Anne Wickerson (Shine). These coaches deserve high praise for their dedication to our kids. The kids are so fortunate to have such fine teachers. And sincere thanks to Rev. Nancy for her encouragement, commitment and fine leadership during a year like none other. We have much to be thankful for and to celebrate!

KIDZONE

2020 was certainly a year like no other. As with most years, it began with much hope and promise. Our KidZone program kicked off the new year continuing with our Spark curriculum as usual. We continue with our three groups, "Spark" for ages three to Grade three, "Glow" for Grades four to six and "Shine" for our Youth, grades seven and up. We presently have approximately 15 children who regularly attend our three divisions. Our Coaches for these classes are Julie Latter and Tracey Abbott in our Spark division, Nicole Vandervoort and Lindsay Haydu-Kunal in our Glow division and our Coach for the Shine class and our Youth Group is Mary-Anne Wickerson. We also have our Nursery which is in the very capable hands of Yasmin.

In January, February, and early March our children explored Daniel and the Lions Den, Love is... and Fruits of the Spirit. And then mid-March came and changed the world as we knew it. The church

building closed to protect our congregation and we suspended KidZone classes. Nancy did Story time for kids on Facebook Live and every Sunday we made a link to Illustrated Ministries available to our families. These resources from Illustrated Ministries contain beautiful colouring sheets and activities that pertain to the scripture reading for each Sunday. In late May/early June we organized a collaborative activity where I asked all our KidZone kids to trace their hands, decorate them and then give them to me at our picnic on June 26th or mail them to me. I used them to make a rainbow and framed them with the saying, "We are each unique and beautiful, but together we are a masterpiece!" At our picnic, I was also able to hand out end of the year bagged



S'more treats. We delivered the treats to those who were not able to attend the picnic.

In September we prepared and dropped off Worship Bags to all our KidZone families. These bags contained: a cloth, a candle, a song sheet, a rock, an origami crane, hot chocolate, and coffee. September also saw the beginning of our collaboration with Woodcliff United, Symons Valley United, and St. Thomas United. Together with these churches, we worked to create weekly recorded KidZone classes. These classes consist of Lighting of the Christ Candle, a Prayer, a Story/Bible reading and an Activity/ Craft. Each month starting in September we have enjoyed all-ages monthly matinee movies. We do these over Netflix Teleparty. From September to December we shared: Despicable Me 2, Small Foot, and Shrek the Halls.

On September 20th we had our first Zoom KidZone class for our Glow division. "Love your neighbour as yourself" was our theme. Since September, our own kidZone Glow class have been meeting in person on Zoom every third Sunday. We have explored the topics of Thankfulness, Peace and Love. Our first ever Virtual Christmas pageant was on December 13th written by our very own, very talented Rev. Nancy Nourse. We had participation from our children, youth, and adults alike. YOUTH MINISTRY

It is my great pleasure and privilege to have the opportunity to work with the Shine Youth Group. They are a remarkable group of youth and I am so very fortunate to get to spend time with them. We have three main focuses for our gatherings as a group – spiritual, social, and service: Spiritual – Weekly Youth KidZone Lessons, Naked Faith Social – Games Nights, Movie Nights, other fun activities

Service – Volunteering in the church and the greater community, helping with the KidZone online activities for the younger kids, and other opportunities throughout the year.

January - early March:

The Youth gathered in person for our weekly Youth KidZone classes on Sunday mornings during worship. At the end of January, the youth prepared and hosted a Youth Luncheon for the congregation coordinated by Michele Gole as a fundraiser for raising tuition for Rendezvous 2020. We had a fun social outing to play Monster Mini-golf in February and then in early March all our planned classes, events and gatherings were suspended.

March -June:



Beginning in March, the Youth programming moved online giving the Youth a variety of opportunities to maintain connection, routine, and to have fun. Using our newly purchased Youth resource – Re:Form, I taught Youth-focused KidZone classes on Zoom on Sundays after the weekly worship service on Facebook Live. As well we helped Rev. Nancy with the youth components for the services each month when there was youth participation.

Weekly Online Games Night: using the Houseparty App, Skibblio, JackBox Games, Board Game Arena, etc. we play a variety of games with an open Zoom window to chat and visit while playing.

Weekly Friday Netflix Party Movie Night: beginning with a check in/visit on Zoom, then using the Netflix Party extension we chose a movie from their list of suggestions. There is a chat window to type in during the movie and then after the movie we resume our Zoom meeting and visit for a bit before signing off. Naked Faith Online: we connect on Zoom the third Friday of the month, then watch the YouTube Worship video and then re-connect and chat afterwards.

I am very glad that we were able to move our Youth programming online -- giving our Youth the opportunity for routine, social connection and spiritual development during the early days of the lockdown. I know that they really enjoyed their time as a group online – we even continued meeting online over the summer for some Games Nights!

September to December:

With the Youth returning to in-person classes in September our online programming continued – the only change being that our weekly movie nights became monthly.

In September, when restrictions still allowed for socially distanced gatherings, we enjoyed a Fireside Games Night and in October before the first snowfall we played mini-golf. As well in September, the Youth were able to volunteer distributing flyers in the neighbourhood promoting the Bottle Drive and

then volunteering on the day of the Bottle Drive. They also volunteered to help with Curbside Pick-up of the Christmas Greenery.

A new component of our Youth program has been our involvement in creating content for the Shared Children's Ministry videos each month. We have enjoyed the opportunity to be creative and reflective writing and sharing prayers and recreating bible stories with paper puppets, etc. As well, the Youth helped with our All-ages KidZone Halloween and Christmas Parties - organizing games to for their younger friends to play. The little ones love the chance to see their older counterparts, and the Youth love to see the little ones! Ongoing:

Monthly Youth Newsletters, frequent email communication with Youth Group families, sharing Zoom links, updates, invitations, WhatsApp Group Chat, etc.

Closing thoughts:

It has been a great challenge refocusing the Youth Ministry at Northminster to provide engaging programming over Zoom and to foster connection for our Youth in an online setting. I am so very pleased and proud that the Youth have continued to attend and want to be part of our online Youth programming. I look forward to the time when we can meet in person again, but until then I am grateful for the many opportunities I have to work with the Shine Youth Group online. COMMUNICATIONS COMMITTEE

Northminster's pivot to Livestream worship in mid-March 2020 defined the work for communications and changed the way our church does ministry.

In less than a week of the Government restrictions on March 15, 2020, we pivoted to Livestream worship. The first service broadcast from Rev. Nancy's kitchen table used a borrowed IPad and was thought to be a temporary solution for a couple of weeks. A new worship broadcast spot was set up in the house after a few weeks, and Rev. Nancy live-streamed worship from her home from March 22 to June 22, 2020.

Livestream worship became a meaningful connection for our congregation. We watched as many Northminster people, including many senior members, pushed their technological learning and went online for the first time to join and see worship. We thank everyone

who donated when we first started broadcasting to cover everything from Livestream subscription costs to a lapel microphone to one cellphone for recording.

The Board approved the new Livestream initiative, and the decision was made to continue Livestream when the congregation returned to in-person worship. The Commemorative Fund approved a grant for new Livestream equipment. With the Commemorative Fund monies, the Northminster purchased a new Ipad Pro, portable and choir microphones, tripods, lighting, small sound mixer, various cords to connect everything, and equipped the sanctuary with a new wifi mesh router. We thank Ernie Abbott and Craig Benoit for installing the latter equipment.

Over the summer, Northminster Livestream Worship was broadcast from a different location each week. The locations included people's homes, backyards, various parks and two Sundays were broadcast from Camp Kasota.

Worship returned to Northminster in mid-September, and we encountered many new challenges. Livestream included multiple people, recordings and many moving pieces. While we may not be meeting in person, the staff and volunteer time to run worship Livestream from the church is similar to when we ran in-person worship before Covid time. This was a new change for everyone, and we all had to learn new roles and new ways of supporting Northminster's ministry.

Sarah Corrigan is our choir director and leads our music ministry. Sarah's work moved from leading the choir to playing and being "THE" singer. Due to restrictions, there is no in-person choir or singing

on Sunday. Sarah has had to record all her music in the evenings and add the words to the hymns' videos. Craig Benoit would take over the role of adding words for the Hymns at the end of the year. In December, Sarah began recording choir members to sing solos or duets at a safe distance.







A new sound and switcher committee was formed, including Len Page, Ted Carter, Ernie Abbott, Brad Lavenne and Sarah Corrigan. The committee's work included a review of our microphones and their use,

a new approach for managing our sound by our volunteers and training new volunteers to run our Switcher. In October 2020, 12 people were trained to run the sound or run our Livestream program called Switcher Studios. We thank all our volunteers, including Suzanne, Mark & Matt Vandervort, Mary Anne Wickerson, Craig Benoit, David Ng, Ken & Jan Huber, Kim Haydu, Len Page, Ted Carter, Ernie Abbott. Craig Benoit decided to be trained on both sound and switcher. We also thank Meishka Corrigan for supporting our sound training and recordings. We added a host to monitor our worship service each Sunday & support those who comment.

We thank Ted Carter for testing and keeping our electrical outlets working and to Ron Hebert for making one of our new pew tripod stands.



Rev. Nancy's role changed too. Rev Nancy is now managing multiple worship services at one time. She can be pre-recording some pieces, prepping live worship and planning readings and music for recording, and going live for worship all in the same week.

Recording is a part of the new work for our congregation. Due to health restrictions and availability, many programs like Supper Church, our music program, or special worship services like Christmas Eve have to be pre-recorded. This work can involve one sound, one switcher person and can involve multiple people being recorded over a two to three hour time period. Social distanced policies must be adhered to and equipment is wiped down between each person being recorded.

During the last nine months of 2020, people discovered Northminster United Church through our Livestream or online events. This change brings a whole new approach to membership and ways to connect to our members and our online audience.

Community Engagement Coordinator

We thank Michele Gole for her role and this role ended in the summer.

Mary Anne Wickerson started her new role in September. Mary Anne jumped right in and learned our social media programs, including Canva and Hootsuite. By the end of 2020, Mary Anne was coordinating all our Social Media posts and creating some videos for our Livestream worship. Mary Anne also coordinated our newsletter and produced the first one in the fall.

Website - We thank Barb Johnson for her work keeping our website up to date.

PASTORAL CARE COMMITTEE

We are very grateful to the UCW for providing and delivering the Christmas baskets and cards. Also thank you to all members of Northminster who made extra phone calls in friendship to support the church family.

There were two seniors who celebrated their 100th Birthdays, Pat Howie and Peggy Nattrass. Through online news members were encouraged to send cards. Flowers and a card were also delivered from Pastoral Care.

Commune-I-Care

This ministry provides an opportunity to communicate with all members of the congregation. Phone calls are made three times a year, in February, May and October. There were 91 families or individuals contacted by our 10 dedicated callers. Any referrals were forwarded to Rev Nancy or the appropriate committee as well as the church office with any changes or new contact information.

Home Communion was not possible this year for seniors.

Independent Small Groups under Pastoral Care

TRUSTEE REPORT

The Trustees of Northminster United Church are responsible for overseeing the operation of the church. At least one Trustee attends the Unified Board meetings during the year.

The Trustees hold all of the property of the congregation, in trust, for the use and benefit of the congregation as part of the United Church of Canada. The activities of the Trustees are restricted and governed by public statute, the United Church's Trusts of Model Deed and by the directions of the Church Board.

One of the most important responsibilities of the Trustees is to ensure that adequate insurance coverage is obtained for the property and regularly reviewed and updated as required. The building and contents of NUC including sound equipment is more than adequately insured with Rogers Insurance Brokers. The policy premium increased by 20% due environmental disasters that occurred during 2020 in the province of Alberta. (fires, hailstorms)

The Trustees met on Dec. 10 after the Special Congregational Meeting of Dec. 6, 2020. There was discussion as to the motion made by the congregation regarding the future of Northminster property and building.

A formal letter was sent to Chinook Winds Region requesting that Chinook Winds Region authorize Northminster United Church to move forward in creating a detailed plan to redevelop Northminster Church property.

The Trustees received a resignation letter in November from Helen Miller, as one of the Trustees. We thank her for her years of service on this committee.

Julie Latter has accepted to fill this vacant position as Trustee which was approved at the Dec. 6 Special Congregational Meeting.

Notification of this change with a list of current Trustees was sent to Chinook Winds Region for their records.

No further business was presented to the Trustees for discussion.

TASK FORCE REPORT

The Task Force was formed to Design a Business Plan to preserve the financial future of Northminster United Church. In the year 2020 the committee held several meetings and had meetings with the Congregation.

January 2020

Completed a Change of Use Feasibility and Costing Report on our current Building. In consultation with Chinook Winds Region we presented four pathways into the future with the following questions:

- a) Keep on as we are now
- b) Keep going in existing building but fund significant new ministry impacts
- c) Mission/Capital Partnership and adaption of existing building
- d) Remove existing building; redevelop new space/new ministry functionality.



February 2020

Provide handouts of question for congregation to answer and have them returned by February 13, 2020.

March 2020

Held a meeting with the congregation to present the four pathways and answer any questions. Give congregation questionnaire to be returned by March 15 with following questions:

- 1) Which option do you feel would be best for Northminster for long term?
- 2) What question do you still have?

April 2020

The vast majority of the responses stated that Option D would be the preferred route to investigate. We presented responses of answers to the two questions that were asked in March to the Board and requested their approval to sent to congregation as well.

Sent document Northminster United Church Planting Seeds for the Future to the congregation.

Met with the Quantum Place Developments representative Jessica Karpat to have them present a proposal of a Feasibility Study for Northminster Redevelopment.

Approached the Board to make available funds to cover the cost of an economic and feasibility study of our site for up to \$25.000.

May 2020

Contracted Quantum Place Developments to complete the Feasibility Study for future development of Northminster.

Task Force completed a review of our current facility with respect to usage and sharing our facility requested by Quantum Place Developments.

June 2020

Met with Quantum Place Developments to discuss Preliminary Market Analysis of our current facility.

July and August No meetings held.

September 2020

Received Final Draft of Feasibility study completed by quantum Place Developments.

October 2020

Quantum Place Developments will provide a summary report of their final report that we can present to the Board.

Presented this summary to the Board on October 28, 2020.


November 2020

NORTHMINSTER UNITED CHURCH NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2020

1. Significant Accounting Policies

The Northminster United Church (the "church") is a registered charitable organization under the Income Tax Act (the "Act") and as such is exempt from income taxes and issues income tax receipts to its donors for income tax purposes. To maintain its status as an organization under the act, the church must meet certain requirements within the Act. In the opinion of the church Board these requirements have been met.

The church generally prepares its financial statements in accordance with "Accounting standards for Not-For-Profit Organizations". The church is a small not-for-profit organization as its average annual revenues are less than \$500,000. The Church has no future commitments or other affairs that require further reporting.

Donations

Donations are received from members of the congregation of the church and are used to fund the operations of the church as directed by the church Board. Specified donations are segregated and forwarded to the project or fund so designated. Pledges or commitments may be made to the church at the donor's discretion. Donations to the church are recorded as income when received.

Volunteer Labour

The operations of the church and its activities are dependent upon the volunteer labour provided by its congregation. No provision has been made in the accounts for the volunteer efforts provided by the congregation.

Fixed Assets

Included in the fixed assets of the church is the cost of land, building and related fixtures, video system and the elevator. No provision is made in the accounts for amortization of the assets as is appropriate for a small not-for-profit organization. The church capitalizes any significant cost of tangible capital assets and insignificant amounts are expensed. Current market and insurable values are more than cost.

2. Cash and Cash Equivalent

Cash and Cash Equivalents is comprised of both Cash and Term Deposits. Term deposits are monies invested from bequests received. All Term Deposits are redeemable on demand and bear interest at various rates. Due to the short-term nature and liquidity of the term deposits, they are part of the cash balance as a cash equivalent. A breakdown between Cash and Cash Equivalents is provided below:

As a result of the COVID-19 pandemic, Northminster United Church applied for and received a \$40,000 loan from the Government of Canada. This loan is repayable to the Government of Canada and includes a forgivable amount of \$10,000 if \$30,000 of the loan is repaid prior to December 31, 2022.
